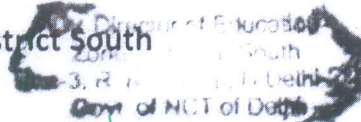
Sir,


Sub:- Upgradation of existing Middle School to Secondary Level (without aid) w.e.f. Academic Session 1982-83.

Sir,

With reference to your application on the above mentioned subject, approval for the upgradation of the above school to Secondary level (without aid) is granted w.e.f. the session 1982-83 subject to the fulfilment of the following terms and conditions:-


1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That Class-IX may be added in the school w.e.f. this academic session ie. 1982-83.
4. That the school shall appoint full time qualified and eligible staff for all classes of the school as per the present norms of the Department.
5. That the school shall equip the science labs and Dom.Sc.room as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
6. That a proper library shall be established and facilities for a separate reading room shall also be made available for students as well as teachers. Adequate number of books for all stages in the school shall be provided.
7. That adequate outdoor games material shall be purchased and made available to the students, and suitable arrangements for play ground be made for students of all classes immediately.
8. That the school shall strictly abide by the provisions of section 10(i) of the Delhi School Edn. Act & Rules, 1973.
9. That the enrolment in a section shall not exceed the number of students calculated @ 12 Sq. Ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi. Proper arrangements for light, ventilation and sanitation be made in each class.

10. That the school shall not run any unrecognised classes or any other unauthorised activity within the school premises and all the recognised classes shall be run at one place at the above address only.
11. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
12. That the scheme of management shall be got approved from the Department immediately.
13. That the service contracts between the management and employees shall be executed immediately.
14. That the school shall not enhance the fees without the prior permission of the Director of Education, Delhi and no development fee will be charged from the students.
15. That the school shall follow the syllabus/books prescribed by the Department.
16. That the medium of instruction in the school shall be strictly in accordance with the rules 6, 7 & 8 of DSER-1973.
17. That the management shall furnish the information to the Director of Education, Delhi vide rule 180 of DSEA-1973 every year by 31st of July.
18. That the school and its records etc. shall be open to officers of the Directorate of Education, Delhi for inspection.
19. That all the conditions/facilities prescribed under rule 50 & 51 of the DSER-1973 shall be made available to the students.
20. That the arrangements for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
21. Provision of two labs. of prescribed size be made immediately and the same suitably equipped as prescribed by the Deptt.
22. That a certificate from the health officer of the local authority be obtained immediately.
23. That the management shall have adequate funds to meet its financial responsibilities for regular payment of salaries and other allowances to its employees through crossed cheques. And facilities for LTC and Medical etc. may also be made available to the teaching & nonteaching staff of the school.
24. That special arrangements shall be made for providing as many co-curricular activities as possible so that all the students get opportunity of participating in the activities.



25. That the school building shall not be used for any commercial, political/religious or for any non-educational activities.
 26. That the management of the school shall create a reserve fund of Rs.12,000/- (in case of total enrolment of 501 to 750) or Rs.15,000/- (in case the total enrolment is between 751 to 1000) in a Joint Account in the name of Director of Education, Delhi and the Manager of the school in any scheduled bank, within a month.
 27. That the school shall not run for the profit of any individual or association or group of individuals.
 28. That the management of the school is hereby warned that in the event of a violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school.
 29. That a report about fulfillment of the above conditions given the extent to which each conditions is fulfilled, shall be sent to the Education Officer every six month.
 30. That the school shall apply for affiliation to CBSE for Delhi Secondary School Examinations and no objection is granted to the school for the same.






